**Rashed Fakhruddin** has worked with Nashville Electric Service for the last 20 years. He has been involved in the YWCA's MEND (engaging men against domestic violence) program, is a founding board member of the American Muslim Advisory Council. He serves on Vanderbilt University's Religious Leaders Advisory Council, Nashville Public Television Advisory Council, and is a board member of You Have the Power and YWCA. He helped initiate a program on gender and violence at Vanderbilt University last spring to bring about more awareness of faith communities engaging in ending domestic violence towards women. Fakhruddin is the president of the Islamic Center of Nashville where he instituted an ongoing program to educate men and women on issues of domestic violence and he is the recipient of the 2015 Pencil Foundation Volunteer of the Year Award.
